In 1913, a first class postage stamp was two cents, Woodrow Wilson was named the 28th President of the United States, and the Woman's Suffrage movement for the right to vote was making headlines. Yet, in the midst of it all, a baby girl by the name of Ann came into the world. That birth is once again celebrated as family and friends from all over the world continue to bestow Ann McClinton with cards, letters, flowers and special commemoratives befitting her 100th birthday. Brightly smiling and wearing a vibrant pink

sweater adorned with beautiful brooches, Ann recalled her wonderful well-wishers as she shared these many items of adornment with me, including her most special congratulatory letter of all – the one signed by President Barack and Michelle Obama. On the morning of her birthday many friends from across the U.S. called to say they had seen Ann's photo and birthday announcement on the Today Show!

Although not actually born in Tampa, Ann calls this city her native home since it was where she spent the majority of her life. As Ann was talking about her early years, she fondly recalled the Stetson area and its Oak Avenue neighborhood that still continues to mean so much to her. An only child, Ann reflected on the large family of aunts and uncles and cousins that formed her society of values, and the special aunt that was like another mother to her. Ann smiled as she shared how some thought she was a bit "spoiled", but yet she doesn't quite agree. She attended Hillsborough County Schools through high school graduation, and received her B.S. from Florida A & M, and continues to be a member of Beta Phi Beta. Ann then went on to New York University where she received her teaching degree in education which would someday enhance young lives in a positive way.

Telephones, televisions, and air-conditioning were unheard of when Ann was a girl. But segregation was alive, especially in the south. When Ann mentioned this to me, I replied that it must have been hard to deal with. Ann disagreed and said, "I kept my pride; I didn't let it bother me". Ann held her head high, maintained her self-respect and dignity, and chose love over hate. There was also a certain amount of Ann's positive demeanor and strength that was derived from her faith. In 1922 Ann began attending Sunday School at Greater Bethel Baptist Church on West Jefferson Street in Tampa, and continued on through her adult life including walking down the aisle of that very same church to one day marry the man of her dreams.

One evening while in college, a sorority sister, who was married to a Chaplain at MacDill AFB, invited Ann and other sorority sisters to have dinner with the troops. Ann fondly recalled how at the after-party, she and her four "sisters" paired off with five young men that they met after the dinner. "Believe it or not", Ann said, "all of those five couples that met that night stayed together through life with the mates they had chosen that evening". A Chief Warrant Officer with the USAF, Robert McClinton, was one of those young men in that group, and more specifically, the one who stole Ann's heart. Although he passed away in 2000, Ann's devotion and love for Robert still flourishes – you can see it in her eyes and hear it in her voice as she talked about the life they shared together, and their marriage at Greater Bethel Baptist Church.

Travels across the continents to Guam, Azores, cities in Europe and Asia were only a few of the stops along the way for Ann and Robert. There was also time spent in Riverside, California where Ann's teaching expertise was a welcome addition to a school for the Native American children. Ann fondly recalled working with children from the Apache, Hopi and Alaskan tribes. The loving and gentle ways that Ann exhibits must have been eagerly welcomed by these young children who were now living away from their families. And to Ann's teaching merit, she was proud to share how many of her students then went on to college and professional successes in life.

Robert and Ann had a child of their own, Charles, who has a Ph.D. in Medical Administration and lives in Cambridge, Massachusetts. With four grandchildren, and great-grandchildren, Ann has beautiful photos on display, as well as many new memories in the making. Hand-drawn and colored pictures from the little ones to Great-Grandmother Ann brighten her walls.

Ann's flair for fashion and her decorative touch lends beauty to her apartment surroundings. Ann keeps a busy social calendar! She shared with me that she was a bowler up until four years ago and laughed as she told me why she stepped away from bowling: "If I took a fall, they would have put it in the paper!" Ann moved to Aston Court from Twelve Oaks four years ago, and absolutely loves her new home and family of friends. As she took me on a guided tour of Aston Court, tens upon tens of friends stopped her to say hello, share a hug, and tell me what a wonderful inspiration Ann McClinton continues to be to those who surround her daily life.



Truly, this was "The greatest generation"

Van T. Barfoot died... Remember the Guy who wouldn't take the flagpole down on his Virginia property awhile back? You might remember the news story several

months ago about a crotchety old man in Virginia who defied his local Homeowners Association, and refused to take down the flag pole on his property along with the large American flag he flew on it.

Now we learn who that old man was. On June 15, 1919, Van T. Barfoot was born in Edinburg, Texas. That probably didn't make news back then but Twenty five years later, on May 23, 1944, Near Carano, Italy, that same Van T. Barfoot, who had in 1940 enlisted in the U.S. Army, set out alone to flank German machine gun positions from which gunfire was raining down on his fellow soldiers.

His advance took him through a minefield but having done so; he proceeded to single-handedly take out three enemy machine gun positions, returning with 17 prisoners of war. And if that weren't enough for a day's work, he later took on and destroyed three German tanks sent to retake the machine gun positions. That probably didn't make much news either, given the scope of the war, but it did earn Van T. Barfoot, who retired as a Colonel after also serving in Korea and Vietnam, a well-deserved Congressional Medal of Honor.

What did make news...was his neighborhood association's quibble with how the 90-year-old veteran chose to fly the American flag outside his suburban Virginia home. Seems the HOA rules said it was OK to fly a flag on a house-mounted bracket, but, for decorum, items such as Barfoot's 21-foot flagpole were "unsuitable".

Van Barfoot had been denied a permit for the pole, but erected it anyway and was facing court action unless he agreed to take it down. Then the HOA story made national TV, and the neighborhood association rethought its position and agreed to indulge this aging hero who dwelt among them.

"In the Time I have left", he said to the Associat-

ed Press, "I plan to continue to fly the American flag without interference." As well he should. And if any of his neighbors had taken a Notion to Contest him Further, they might have done well to read his Medal of Honor citation first. Seems it Indicates Mr. Van Barfoot wasn't particularly good at backing down.

Some members still prefer using the old fashioned means of out-reach to their legislators, the telephone, and MOAA has a direct Toll-free line to the Capitol switchboard as well: (866)272-6622. Either way, you can Storm the Hill, too, without ever leaving your home. Your support for these actions is crucial and the collective action of all of our MOAA members will have a much greater impact when MOAA representatives visit every legislator's office to advocate for these issues on April 10th.

My parting shot for this month's president's message is to start seriously thinking about registering for the June Florida Council of Chapters annual convention. It will be here before you know it!
